

Section 3. The polls for the Election will be open between the hours of 7:00 a.m. and 7:00 p.m. on the day of the Election.

Section 4. At the Election, the following question shall be submitted to such qualified, registered electors of the District:

#### **GENERAL OBLIGATION BOND QUESTION**

At the Election, the following question shall also be submitted to such qualified, registered electors of the District:

#### PUBLIC SCHOOL CAPITAL IMPROVEMENTS TAX QUESTION

Section 5. The tax contemplated by the capital improvements tax question shall be in addition to the tax contemplated by the bond question and to any tax imposed to pay debt service on the bonds, or for any other purpose. Such capital improvements tax shall be authorized pursuant to the Public School Capital Improvements Act, *i.e.*, NMSA 1978, Sections 22-25-1 through 22-25-10.

Section 6. A person is a qualified elector of the District if on the day of Election he or she is a citizen of the United States, at least 18 years of age, and a resident of the District. In order to vote, qualified electors of the District must have previously registered with the County Clerk of Doña Ana County, or the County Clerk of Otero County or any voter registration agent in accordance with law. Section 8. Voting on election day and absentee voting in person, as provided in Section 6 above, shall be by a voting system, defined in NMSA 1978, Sections 1-9-1 *et seq.* Other absentee voting shall be by paper ballot. At least one voting system shall be used at the polling place for each Voting District.

WHEREAS, the Board of Education of the Gadsden Independent School District No. 16 ("Board" and "District," respectively) on its own motion has by its Resolution and Proclamation of Special School Bond Election and Public School Capital Improvements Tax Election, adopted this 10<sup>th</sup> day of November 2005, ordered that at the election to be held within the District, Doña Ana and Otero Counties, New Mexico, on the 7<sup>th</sup> day of February 2006 ("Election"), there shall be submitted to the qualified registered electors of the District, the question of issuing the District's general obligation bonds in an amount of not exceeding \$38,000,000 for the purpose of erecting, remodeling, making additions to and furnishing school buildings and purchasing or improving school grounds and purchasing computer software and hardware for student use in public school classrooms, providing matching funds for capital outlay projects funded pursuant to the Public School Capital Outlay Act or any combination thereof and the question of imposing a public school capital improvements tax.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE GADSDEN INDEPENDENT SCHOOL DISTRICT NO. 16, CONSTITUTING THE GOVERNING BOARD OF SAID DISTRICT IN THE COUNTIES OF DOÑA ANA AND OTERO AND THE STATE OF NEW MEXICO:

Section 1. The Resolution and Proclamation of Special School Bond Election and Public School Capital Improvements Tax Election, previously adopted on November 10, 2005, shall be published in Public Proclamation form twice in full, in English and Spanish, in the Albuquerque Journal, Albuquerque, New Mexico, being the legal newspaper having general circulation within the District. The Superintendent of Schools of the District ("Superintendent") shall forthwith file said Resolution and Proclamation of Special School Bond Election and Public School Capital Improvements Tax Election, with the County Clerk of Doña Ana County as the county clerk of record ("County Clerk of Record"), who also shall serve as administrator of the Election, pursuant to NMSA 1978, Section 1-22-12, and who shall be responsible for publishing the proclamation as described above. The Superintendent shall also obtain from said County Clerk of Record executed copies of the Certificate of Filing of Resolution and Proclamation of Election.

Section 3. Pursuant to NMSA 1978, Section 1-22-10, the County Clerk of Record

shall prepare the ballots for the Election, which shall be printed by the thirtieth (30th) day preceding the Election. The cost of printing the ballots shall be paid by the District. The printed ballot shall contain the questions to be submitted to the registered qualified electors of the District, as more fully described in Section 4 below.

Section 4. The voting systems to be used shall carry a ballot label to be the submission clause for the bond question and the tax question set forth in the form demonstrated in Section 4 of the Resolution and Proclamation of Special School Bond Election and Public School Capital Improvements Tax Election and shall be printed in English and Spanish with plain, clear type in black ink on white material of such size as will be compatible with the voting systems. The complete bond question and tax question to be submitted, in English and Spanish, shall be placed near the voting systems in plain view of the qualified voters, so that the complete questions may be examined before they vote. The ballot labels for the bond question and the tax question shall be in substantially the following form:

Section 4. At the Election, the following question shall be submitted to such qualified, registered electors of the District:

#### GENERAL OBLIGATION BOND QUESTION

"Shall the Board of Education of the Gadsden Independent School District No. 16, Counties of Doña Ana and Otero, State of New Mexico, be authorized to issue general obligation bonds of the District, in one series or more, in the aggregate principal amount of not exceeding \$38,000,000 for the purpose of erecting, remodeling, making additions to and furnishing school buildings and purchasing or improving school grounds and purchasing computer software and hardware for student use in public school classrooms, providing matching funds for capital outlay projects funded pursuant to the Public School Capital Outlay Act or any combination of these purposes, said bonds to be payable from general (ad valorem) taxes and to be issued and sold at such time or times upon such terms and conditions as the Board may determine?"

At the Election, the following question shall also be submitted to such qualified, registered electors of the District:

#### PUBLIC SCHOOL CAPITAL IMPROVEMENTS TAX QUESTION

Section 5. The tax contemplated by the capital improvements tax question shall be in addition to the tax contemplated by the bond question and to any tax imposed to pay debt service on the bonds, or for any other purpose. Such capital improvements tax shall be authorized pursuant to the Public School Capital Improvements Act, *i.e.*, NMSA 1978, Sections 22-25-1 through 22-25-10.

Section 6. A person is a qualified elector of the District if on the day of Election he or she is a citizen of the United States, at least 18 years of age, and a resident of the District. In order to vote, qualified electors of the District must have previously registered with the County Clerk of Doña Ana County, or the County Clerk of Otero County or any voter registration agent in accordance with law. Any qualified elector of the District who is not now registered and who wishes to vote at the Election should register during regular office hours prior to 5:00 p.m. on January 10, 2006, being the twenty-eighth day immediately preceding the Election at the office of the County Clerk of Doña Ana County, Doña Ana County Courthouse, Las Cruces, New Mexico, or, the County Clerk of Otero County, Otero County Courthouse, Alamogordo, New Mexico, or by any registration agent at a designated agency as provided in NMSA 1978, Sections 1-4-47 and 1-4-48.

Section 7. Absentee voting will be permitted in the manner authorized by NMSA 1978, Sections 1-6-1 *et seq.*; provided, however, that pursuant to NMSA 1978, Section 1-22-19, qualified electors may also vote absentee in person at the office of the County Clerk of Doña Ana County, during the regular hours and days of business from 8:00 a.m., January 13, 2006, being the twenty-fifth day preceding the Election, until 5:00 p.m., February 3, 2006, being the Friday immediately prior to the Election.

Section 8. Voting on election day and absentee voting in person, as provided in Section 6 above, shall be by a voting system, defined in NMSA 1978, Sections 1-9-1 *et seq.* Other absentee voting shall be by paper ballot. At least one voting system shall be used at the polling place for each Voting District.
