## PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM ADMINISTERED BY NEW MEXICO DEPARTMENT OF TRANSPORTATION

WHEREAS THE Gadsden Independent School District and the New Mexico Department of Transportation have entered into a joint and coordinated effort in Cooperative Agreement Project Number SP-1-07 (969) and Control Number 87502 known as LGRF Project for year 2006/2007 to "Subgrade, base course, curb and PMBP – student drop-off at Sunland Park Elementary School" within the control of the Gadsden Independent School District.

WHEREAS, the total cost of said project will be Twenty Thousand Three Hundred Fifty Nine and 00/100 Dollars. \$20,359.00 to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation share shall be 75% or \$20,359.00
- Gadsden Independent School District's proportional matching share shall be 25% or \$6,786.33

TOTAL PROJECT COST IS \$27.145.33

Scope of work: "Subgrade, base course, curb and PMBP – student drop-off at Sunland Park Elementary School" (See attached drawing and estimate)

Gadsden Independent School District shall pay all costs, which exceed to total amount of Twenty Thousand Three Hundred Fifty Nine and 00/100 Dollars \$20,359.00

Now therefore, be it resolved in official session the Gadsden Independent School District determines, resolves, and orders as follows:


That the Cooperative agreement for "Subgrade, base course, curb and PMBP – student drop-off at Sunland Park Elementary School" is adopted and has a priority standing.

NOW therefore, be it resolved by the Gadsden Independent School District to enter into Cooperative Agreement Project Number SP-1-01 (969) Control Number 87502 with the New Mexico Department of Transportation for LGRF Project for year 2006.2007 to "Subgrade, base course, curb and PMBP – student drop-off at Sunland Park Elementary School" within the control of the Gadsden Independent School District in Sunland Park, New Mexico.
