All meals and snacks snat be prepared in the kitchen operating with a current passing certification inspection from the State of New Mexico Environmental Department or have other local or Federal health certification. Health and sanitation conditions are to be met by the vendor at all times. All meals and snacks must be prepared under sanitary conditions and held, as well as delivered to the Center at proper temperatures to prevent food becausillness. Meals are to be made available upon request to New Mexico State agency staff for periodic inspection by the local health department or an independent agency to determine if hacteria levels conform to the levels which may be present in meals prepared or served by other establishments in the locality. The results of these inspections shall be submitted to the center and the state agency

## IV. Ordering and Delivery Procedures:

The following facilities which have been approved for participation are to have meals delivered to each location, each day, as specified.

Increases or decreases in the number of meals ordered may be made by the HELP-New Mexico Pre-K. Program as needed by submitting a change order for the number of meals required for the next day of service, to the delivery person at the time of current day delivery or by calling the vendor's office (Sunrise Cafetoria) with at least \_\_4\_ hours of prior notice.

### V. Repord Keepings

The vendor shall maintain such records as the institution will need to meet it's responsibilities and shall promptly submit invoices and delivery reports to the center no less frequently than monthly.

The books and records of the vendor pertaining to the institutions's food service operation shall be available for inspection and audit by representatives of: The State Agency, The USDA or The US General Accounting Office at any reasonable time and place, for a period of three years from receipt of final payment under the contract, or in
