Due to the delay in completing the calculation of the 2007-2008 carryover funds, districts may submit the BAR prior to June 12, 2009 for FY 2009 or after July 1, 2009 for FY 2010. The carryover funds must be obligated by September 30, 2009 and liquidated (expended) by November 15, 2009.

This grant is subject to the provisions of Title I of the Elementary and Secondary Education Act, and the General Education Provisions Act (P.L. 103-382). This grant is also subject to the Title I Regulations in 34 CFR Part 200 and the Education Department General Administrative Regulations (EDGAR) in 34 CFR Parts 76 (Except for 76.650 – 76.662 Participation of Students Enrolled in Private Schools), 77, 80, 81, 82 and 85.
