MEMORANDUM OF UNDERSTANDING

FOR eLEARNING COURSE ACCESS

BETWEEN

THE STATE OF NEW MEXICO PUBLIC EDUCATION DEPARTMENT

AND

GADSDEN INDEPENDENT SCHOOL DISTRICT

THIS UNDERSTANDING is entered into by and between the State of New Mexico Public Education Department, hereinafter referred to as the "DEPARTMENT," and the Gadsden Independent School District, hereinafter referred to as the "DISTRICT".

WHEREAS, the DEPARTMENT desires to provide statewide eLearning services via the Innovative Digital Education and Learning—New Mexico (IDEAL-NM) program,

WHEREAS, the DISTRICT desires to engage, and the DEPARTMENT is willing to provide eLearning services to the DISTRICT,

NOW THEREFORE the parties hereby agree as follows;

1. Scope of work:

- A. The DEPARTMENT shall make available eLearning courses via the learning management system platform of the IDEAL-NM program. The courses that are offered will include the existing catalogue of IDEAL's courses, and any new courses in development.
- B. The DISTRICT will provide student access to IDEAL-NM eLearning courses and pay the Southwest Regional Education Center, who is the fiscal agent for the DEPARTMENT, the sum of \$200 per student per course per semester seat as its share of cost allocation. Payment for the course will be due upon receipt of invoice from the DEPARTMENT.
- 2. **Term:** This Understanding will become effective upon approval by the parties. It shall terminate on June 30, 2012. It may be terminated by either of the parties upon written notice delivered to the other party at least thirty (30) days prior to the intended date of termination. Upon termination all obligations incurred under this understanding shall terminate.
- 3. **Strict accountability of all Receipts and Disbursements:** Each party shall be strictly accountable for all receipts and disbursements under this agreement.
- 4. **Amendment:** This understanding shall not be altered, changed, or amended except by instrument in writing executed by the parties.
- 5. **Appropriations:** Performance under this Understanding is contingent upon sufficient authority and appropriation granted by the New Mexico State Legislature.
- 6. Governing Law: This Understanding shall be governed by the laws of the State of New Mexico.
