Dear Ms. Cynthia Nava, Superintendent:

The New Mexico Public Education Department (PED) is pleased to announce that reimbursement for dual credit instructional materials is available for New Mexico public, charter, and state-supported schools for the 2009-2010 school year. Please note: this is a one time allocation, only, for school year 2009-2010.

House Bill 2, 2009 (page 226 line 12-19) makes an appropriation for Dual Credit Instructional materials. Estimated funds are based on the amount each school requested in the annual Program Budget Questionnaire. Reimbursements may be requested between October 1 and December 1, 2009 for first semester and between February 1 and April 1, 2010 for second semester. Your district Allocation is \$60,000.00.

To receive reimbursement, the dual credit instructional materials must be for a course approved by Higher Education Department (HED) and through a college/university for which the district has an approved agreement. Therefore, when requesting reimbursement, please note the cost of the materials, as well as which courses and which college/university taught the course. The code number for this fund is 27103.

Eligibility: All public, charter, and state-supported schools.

Use of Funds: Reimbursement for approved dual credit course materials.
