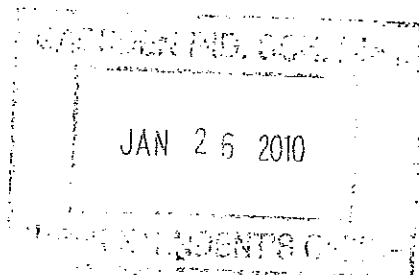

Dear Ms Nava:

As a result of the 2009 Legislative session, there was a special appropriation in the amount of \$1,000,000 for After School Enrichment Programs. As you are aware, [Executive Order 2009-044 or HAFC Committee Substitute for House Bill 17 and Senate Bill 33 (as amended)], in the recent special session, was issued or became law on November 12th, 2009. This legislation provides for various reductions of state funds and programs to ensure solvency. This letter is to inform you that your District's award of \$144,000 for After School Enrichment has been reduced in the amount of \$10,368 for a revised award total of \$133,632.

Please submit an electronic Budget Adjustment Request (BAR) in the amount of \$10,368 for the reduction, utilizing the Fund Code 27168 and Revenue Code 43202.

Please submit the electronic BAR utilizing the Public Education Department (PED) Operating Budget Management System (OBMS) website. The Flowthrough BAR process is located on the PED website at www.ped.state.nm.us. I also encourage you to work closely with your school district finance person.
