

Dear Ms. Nava:

This letter is to inform you that your district's **Family and Youth Resource Act Program** (FYRA) award for the following schools has been <u>increased</u> by the amount of \$ 20,000. The increase is made available based on reserve funds.

## School(s) to be served

Santa Teresa, Chaparral, Gadsden High Schools 2009-2010 SY AWARD \$ 20,000

Funding under this award may continue to be funded if the percentage of students eligible for the free and reduced-fee price lunch program drops below 80 percent, so long as the schools maintain an average of 80 percent or more for any three-year period. Furthermore, any future funding is contingent upon legislative appropriation.

This award must be used as specified by legislation and allowable under the application submitted and approved through the **School & Family Support Bureau**.

These funds will be reimbursed and must be expended in accordance with legislative language.

In order to budget these funds, please submit an electronic Budget Adjustment Request (BAR) increase utilizing the PED OBMS (Operating Budget Management System) website. I also encourage you to work with your school district finance person that has been notified of this new process for submission.
