Dear Superintendent Nava:

In accordance with legislative language in SB 144, Gadsden Independent Schools has been awarded \$135,696.60 for the purpose of funding the Elementary Breakfast Program. In the following elementary schools funding is as follows:

Funding under this award must be used as specified by legislation and approved through the Student Nutrition Bureau. The funded amount indicated above correlates to the federal per-meal reimbursement rates recently released by the United States Department of Agriculture (USDA) for the 2011-2012 SY. In addition, for elementary schools that are operating on a four (4) day school week, awards will be adjusted accordingly. The Elementary Breakfast Program Funds are allocated on a request for reimbursement basis submitted through the Public Education Department (PED) Operating Budget Management System (OBMS); and on a per

meal USDA reimbursement rate supported by a documented spreadsheet that will be attached to all requests for reimbursement (directions forthcoming).

In order to budget these funds, please:

- 1. Fill out the attached assurance form and fax or email a signed copy to Ms. Jasmin Hendrickson at jasmin.hendrickson@state.nm.us or fax 505-827-1815.
- 2. Submit an electronic Budget Adjustment Request (BAR) utilizing the PED OBMS website. The Flowthrough BAR Process is located on the PED website at <a href="www.ped.state.nm.us">www.ped.state.nm.us</a>. Please submit an electronic BAR in the amount of \$135,696.60 utilizing 27155 (Fund Code) and 43202 (Revenue Code).
- 3. If you have any questions, I encourage you to work with your school district finance person who has been notified of the new process.

Please note: SB 144 requires that elementary schools in which 85% or more of enrolled students are eligible for free or reduced-price lunch under the National School Lunch Act of 1946 during the prior school year and/or elementary schools that receive state funds for the elementary breakfast program must:

- 1. Provide breakfast after the bell unless a waiver is granted by the Public Education Department; and
- 2. Ensure that instruction is occurring simultaneously while breakfast is being served.

Schools applying for a waiver will not be eligible for state funding for the Elementary Breakfast Program. If you wish to apply for a waiver please contact Leighann Lenti at leighann.lenti@state.nm.us.
