Re: Voting Convenience Centers.

Dear Mr. Yturralde:

As you may know, the Doña Ana County Bureau of Elections is planning on operating 39 Voting Convenience Centers ("VCC") in next year's primary and general elections in place of the 80 some-odd individual and consolidated polling places that have served to date, at great county expense. A VCC is a location serving as a polling place at which any registered voter may vote regardless of the precinct in which the voter is registered. Ballots are printed that coincide with the precinct in which the voter is registered, listing only the names of candidates for whom the voter is entitled to vote.

Because of the greater number of Election Day voters at each location and the larger array of voting equipment required to serve them, VCC's require building locations with large interior spaces, such as cafeterias and gymnasiums. With this in mind, in addition to using certain county-run facilities, the Bureau of Elections proposes to use the GISD facilities listed in the attached chart.

Obviously, use of these types of facilities is impractical if school is in session. Security risks exist for teachers and students when non-school personnel frequent the buildings, voter parking spaces are limited when school staff is present, and simultaneous use of the facilities by voters, poll workers and students is infeasible.

This is not a problem for the June 5, 2012, primary election because school is out at that time. However, if school is in session on Tuesday, November 6, 2012, the county will be unable to operate VCC's as planned.

Accordingly, in preparing the district's calendar for the coming year I would very much appreciate it if GISD would declare Tuesday, November 6, 2012, as a school holiday in order to let this important program proceed.
