**Executive Summary**  
**April 30, 2012**  
**Monthly Budget Report**

1. Operational Fund Revenues as of April 30, 2012 - \$79,056,621 which represents 84.39% of budgeted Revenues.
2. Operational Fund Expenditures as of April 30, 2012 - \$69,903,223 which represents 71.33% of budgeted Expenditures.
3. The April 30, 2012 Operational Fund Cash Balance before loans was \$16,324,159. The cash balance after temporary loans of \$1,803,553 to the grant funds was \$14,520,606. Grant funds that reported a negative cash balance as of April 30, 2012 totaled \$1,414,334 which represents an increase of \$585,184 over the March 31, 2012 negative balances. The remaining difference of \$389,219 is from outstanding loans from June 30, 2010 which are pending PED approval of the permanent cash transfer requests.
4. As of April 30, 2012, the PED and other grant funding agencies owed the District approximately \$1,795,081 for current year grant fund expenditures. PED owed the District approximately \$1,662,781 for capital project expenditures. These amounts are not reflected in the temporary loans noted in Item 4 above. The negative cash balances noted in Item 4 are a result of the outstanding amounts owed to the District.
5. Total Revenues for all funds as of April 30, 2012- \$129,046,053. Of the total revenues received the Operational Fund accounted for 61.26%, the Grant Funds 13.05%, Building Funds 9.69%, Debt Service Funds 5.95%, Student Nutrition 5.61% and all other funds 4.44%.
6. Total Expenditures for all funds as of April 30, 2012- \$114,608,773. Of the total expenditures incurred, the Operational Fund accounted for 60.99%, the Grant Funds 13.25%, Building Funds 7.83%, Debt Service 7.66%, Student Nutrition 5.60% and all other funds 4.67%.
7. Direct Instruction expenditures plus encumbrances for the Operational Fund as of April 30, 2012 were \$57,610,546 or 64.33% of the total Operational Fund expenditures.

**Selected items from March 2012 Report:**

1. Operational Fund Revenues as of March 31, 2012 - \$71,158,392 which represents 75.96% of budgeted Revenues.
2. Operational Fund Expenditures as of March 31, 2012 - \$62,520,382 which represents 63.80% of budgeted Expenditures.
3. Total Revenues for all funds as of March 31, 2012- \$118,256,741. Of the total revenues received the Operational Fund accounted for 60.17%, the Grant Funds 13.24%, Building Funds 10.53%, Debt Service Funds 6.27%, Student Nutrition 5.46% and all other funds 4.33%.
4. Total Expenditures for all funds as of March 31, 2012- \$104,273,621. Of the total expenditures incurred, the Operational Fund accounted for 59.96%, the Grant Funds 12.98%, Building Funds 8.12%, Debt Service 8.39%, Student Nutrition 5.49% and all other funds 5.06%.
5. Direct Instruction expenditures plus encumbrances for the Operational Fund as of March 31, 2012 were \$57,264,241 or 64.42% of the total Operational Fund expenditures.

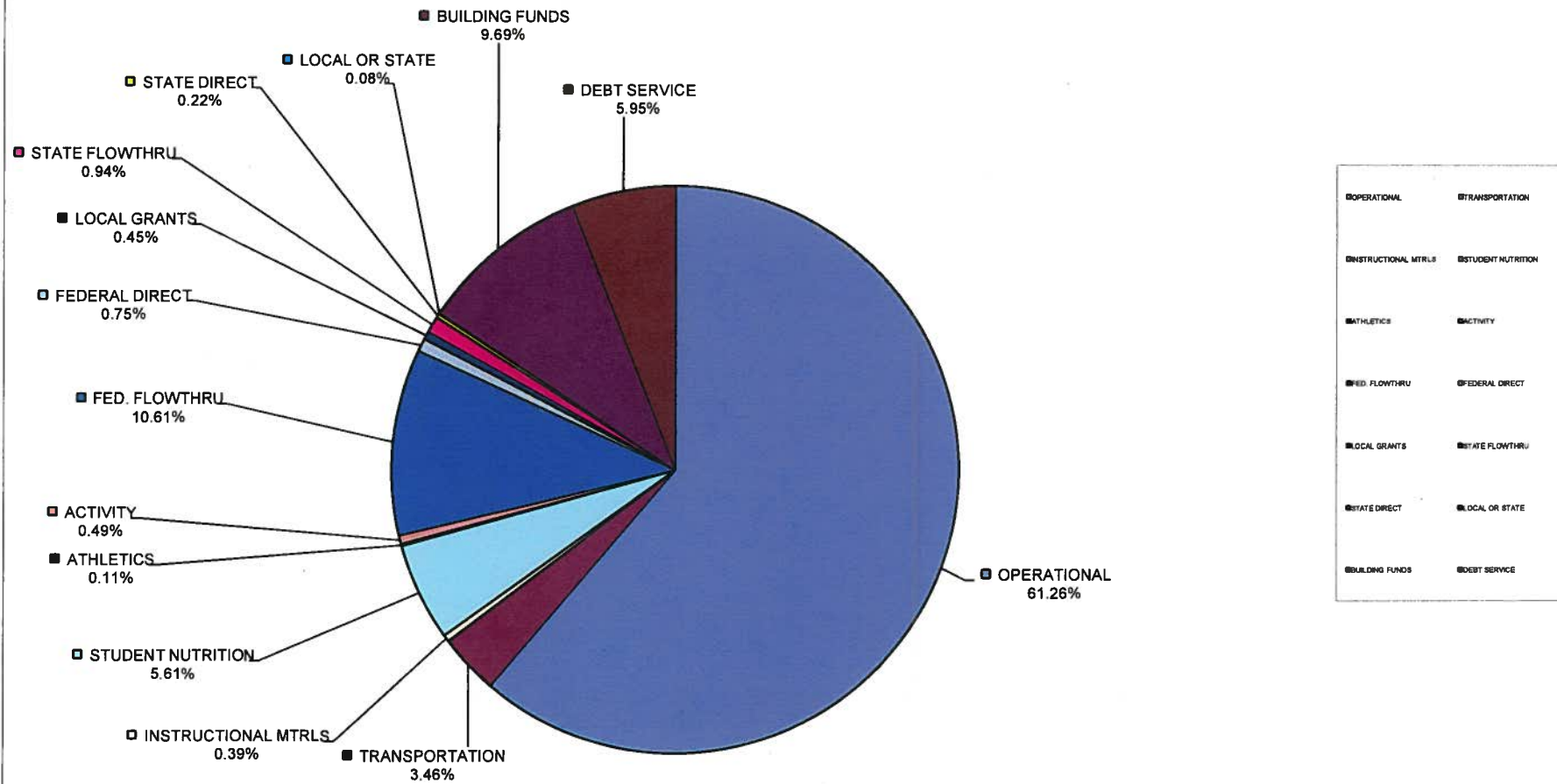

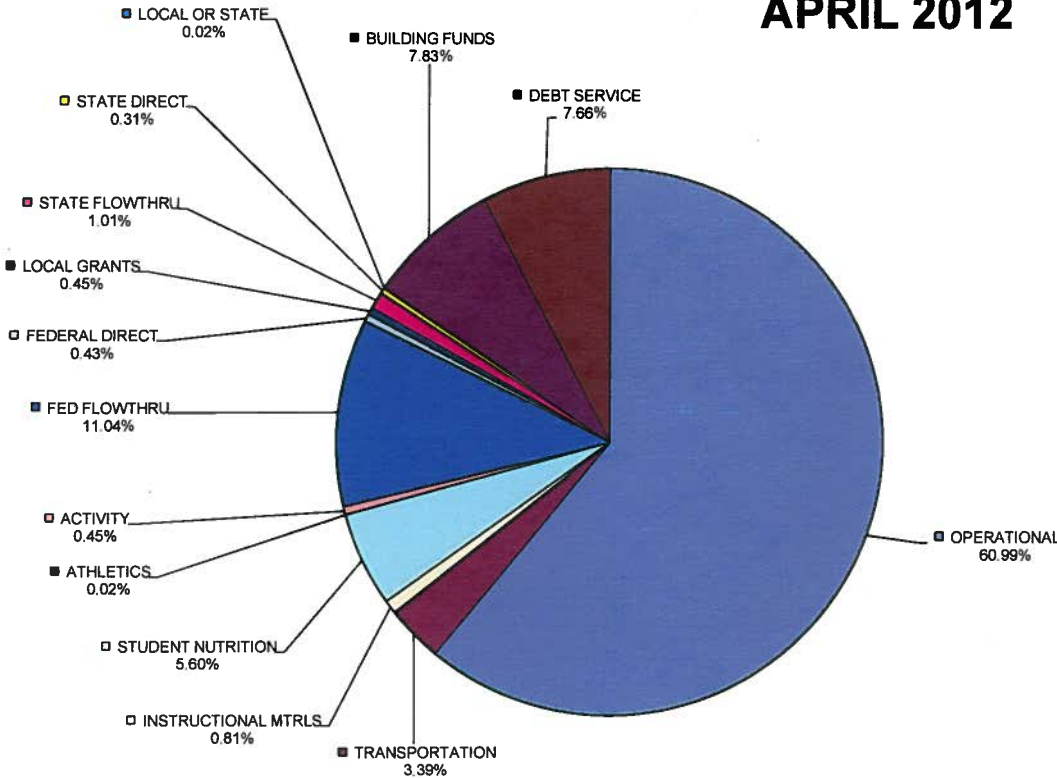

# GISD 2011-12 REVENUES BY FUND APRIL 2012

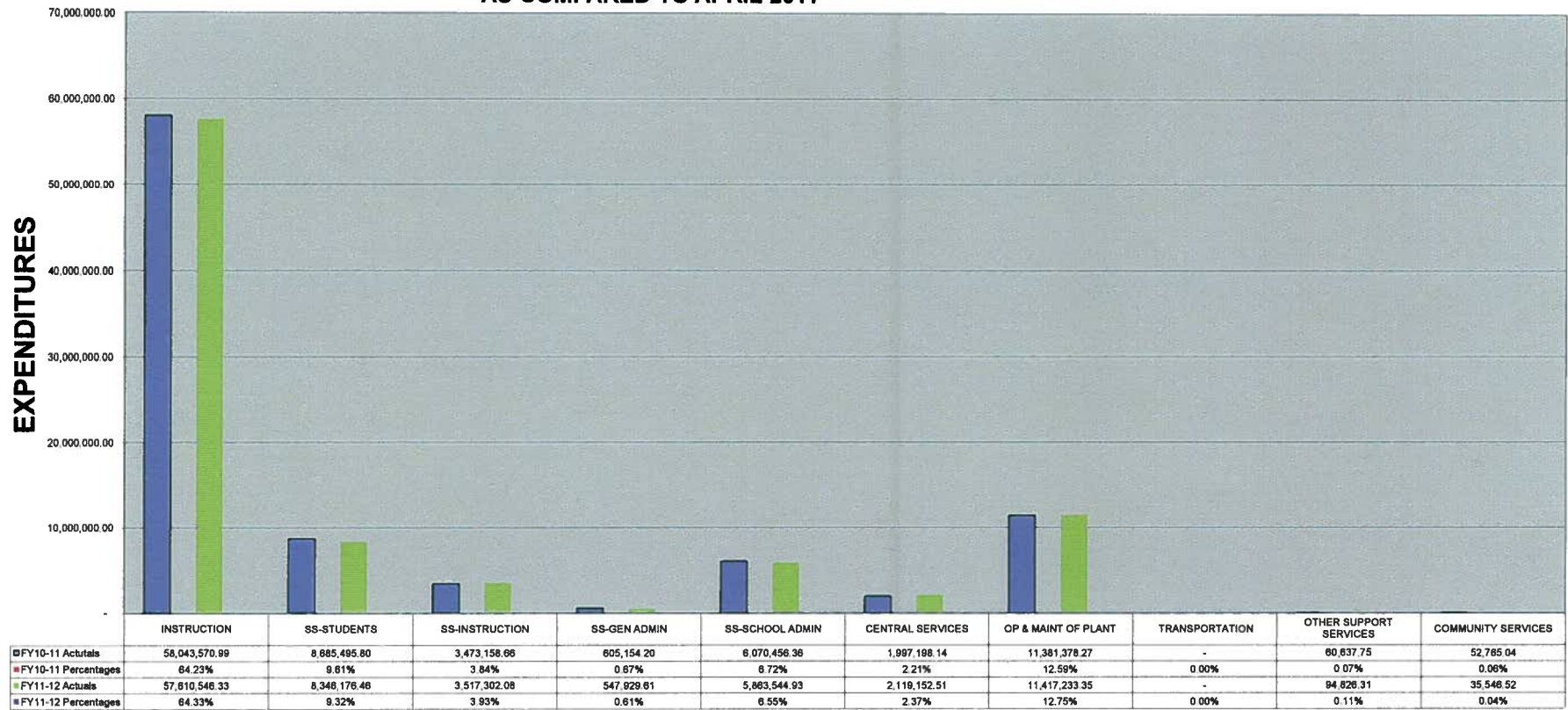


# GISD 2011-12 EXPENDITURES BY FUND APRIL 2012

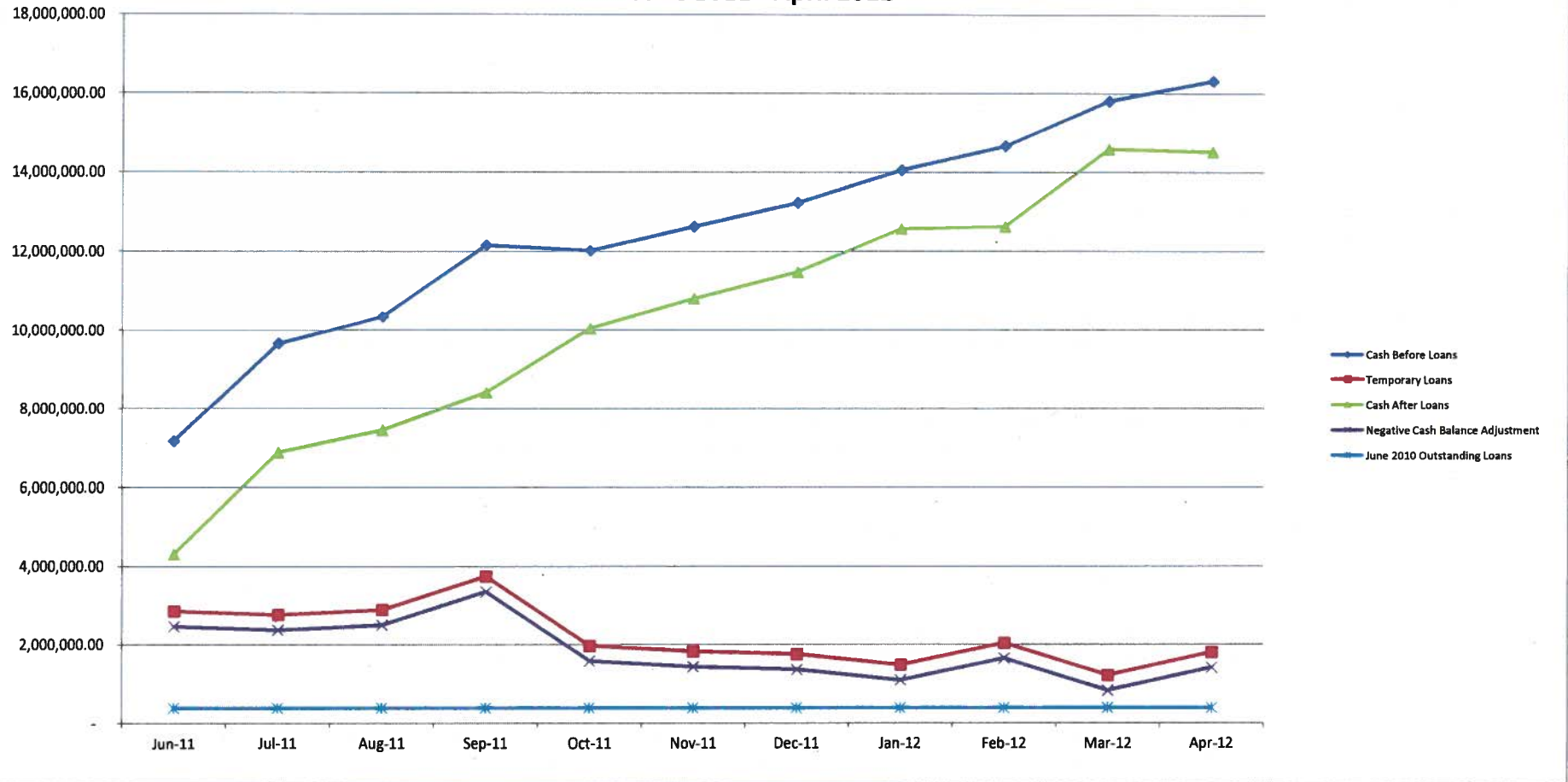

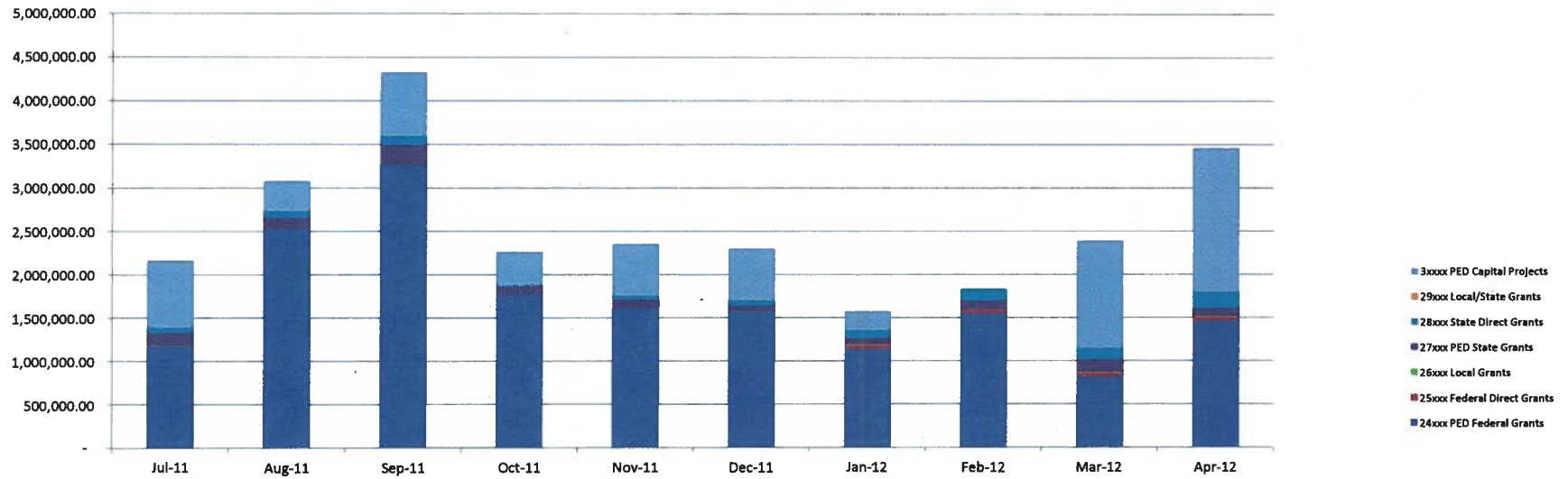
**OPERATIONAL FUND EXPENDITURES AND ENCUMBRANCES FOR APRIL 2012
