The Breakfast for Elementary Students program funds are allocated based on Section 22-13-13.2 NMSA 1978. School districts and charter schools are reimbursed for breakfasts served based on a per-meal United States Department of Agriculture (USDA) reimbursement rate supported by the attached document. Request for reimbursement must be submitted via the PED Operating Budget Management System (OBMS).

Funding under this award must be used as specified according to Section 22-13-13.2 NMSA 1978 and 6.12.9 of the New Mexico Administrative Code (NMAC) and approved through the Public Education Department (PED) Student Nutrition Bureau guidelines.

The Breakfast for Elementary Students program requires that elementary schools in which 85% or more of enrolled students are eligible for free or reduced-price lunch under the National School Lunch Act of 1946, during the prior school year, receive state funds for the program school district(s) and charter school(s) must do the following:

- 1. Provide breakfast for elementary students unless a waiver is granted by the PED in accordance with 6.12.9.9 of the NMAC.
- 2. Ensure that instruction is occurring simultaneously while breakfast is being served.

If you feel that the implementation of this program will be a burden on your school district or charter school and would like to apply for a waiver, please contact Regina A. Madrid at reginaa.madrid@state.nm.us or (505) 827-1814.

The Student Nutrition Bureau will closely monitor requests for reimbursement and program activity to ensure that each school district and charter school that is awarded state funds for the Breakfast for Elementary Students program is participating in the program unless a waiver has been granted.

In order to budget these funds, please work with your district business manager and complete the following:

- 1. Fill out and sign the attached assurance form and fax it to Barbara-Vigil-at (505) 827-1815 or email it to barbara.vigil@state.nm.us.
- 2. Submit an electronic Budget Adjustment Request (BAR) utilizing the PED OBMS website located at www.ped.state.nm.us. Please submit an electronic BAR in the amount of \$114,962.69 utilizing 27155 (Fund Code) and 43202 (Revenue Code).
