When submitting BARs, please keep in mind that CEIS (Fund 24112) and Private School Proportionate Share (Fund 24115) are inclusive of your IDEA B Entitlement (Fund 24106) and IDEA B Preschool (Fund 24109) award, and not in addition to; therefore, your cumulative budget shall not exceed the total amount of funds awarded for Funds 24106 and 24109. Funding under this award must be used in compliance with the applicable provisions of IDEA-B, as follows:

- Only to pay the excess costs of providing special education and related services to children with disabilities;
- To supplement state, local and other federal funds and not to supplant such funds; and
- Not to reduce a Local Educational Agency's (LEA) Maintenance of Effort (MOE) for the education of children with disabilities below the preceding year's level except as allowed by 34 CFR §§ 300.204 and 205. [20 U.S.C. 1413(a)(2)(A), 34 CFR § 300.202]

Since the district's/charter's sub-grant was considered approved, funds cannot be transferred from one fund code to another or between function codes without submitting an amended sub-grant, to include the required signatures and a BAR. Funds can never be transferred out of the private school's proportionate share or mandatory CEIS fund codes and will carry over in the next year under the same fund code. In addition, those funds set aside for mandatory CEIS due to significant disproportionality must remain in the appropriate fund code (24112) for the carry over period.

When submitting your district's electronic BAR to bring the district's budget authority in alignment with this award letter, please use the fund codes identified above and revenue code 44500. Please adhere to the following timelines required for obligation, liquidation and RfR submission:

- Submit your BAR and a copy of this letter through OBMS by February 28, 2013.
- The FY 2011-12 redistribution and carryover amounts indicated above must be obligated by June 30, 2013 and expended by September 30, 2013. Final requests for reimbursement for this funding must be received no later than October 25, 2013.
- The last day to submit requests for reimbursements for FY 2012-13 is July 5, 2013.
