NOW, THEREFORE, in consideration of the mutual promises and covenants herein expressed, the parties do hereby agree as follows:
Purpose of Agreement. GCU will offer the following programs to Partner: (List Programs)

Performance by Partner. To the extent possible without affecting business operations, Partner shall provide classroom space (if needed) and support at no charge to GCU. Partner shall work with GCU to create and make available to Partner marketing materials that describe and provide prospective students with all relevant information regarding each Program.
Performance by GCU. GCU shall provide the content, instruction, and academic oversight of the above mentioned Programs. GCU shall provide the services enumerated in "Exhibit A" to this Agreement. GCU shall also include the Programs in its general marketing efforts and, at the request of Partner, shall conduct periodic marketing efforts specifically targeted at potential students for the Programs. GCU shall also conduct all necessary public relations activities designed to enhance and further the status and reputation of the Programs.
Terms of Agreement. This Agreement shall be effective as of the date indicated above and shall remain in effect until terminated by either party. Either party may terminate this Agreement with sixty (60) days written notice. Any student enrolled in a Program at the effective date of termination will be assisted by the parties in completing the Program in which such student is enrolled at the time of termination.
Payment Structure. Students will be assessed tuition at current GCU rates.
Continuous Enrollment. The scholarship will only be awarded if students remain continuously enrolled in the Program and take the required courses necessary to complete the Program. Continuously enrolled is defined as no breaks greater than fourteen (14) days unless an approved leave of absence has been granted by GCU.

Partner Benefits Include:

- 1. Eligible employees shall receive a 10% scholarship on all degree programs, with a start date in 2013. This shall be available as long as an Educational Alliance Agreement is in place, and renewed each year.
- 2. GCU shall provide a welcome page for employees interested in learning more about GCU's educational offerings.
- 3. GCU shall provide a monthly newsletter for Partner's staff and faculty.
- 4. GCU shall provide marketing literature and conference center/campus/district level informational sessions to Partner to promote continuing education and support employee educational goals.
- 5. GCU shall provide a local University Development Representative as a primary contact and employee resource.

Partner Requirements Include:

- 1. Partner shall work to communicate to its employees the benefits and variety of programs offered by GCU.
- 2. Partner shall provide GCU with a list of employees and internal email addresses for monthly updates of program offerings and options or shall send out communication to district wide personnel regarding benefits, variety of programs offered, and district events conducted by GCU.
- 3. Partner shall provide a district location for quarterly informational seminars for teacher education.
- 4. Partner shall provide teachers the convenience and opportunity of one (1) local school event at each school hosted by GCU to provide information regarding the program offerings at GCU.
- 5. Partner shall build and maintain a link from its intranet and/or learning portal to the welcome page on the GCU website. Partner shall provide a point of contact within the IT department for web links and internet access.
- Partner shall participate in GCU's Student Teaching Affiliation Agreement (attached) which establishes the terms and conditions under which students of GCU may participate in Student Teaching Internships, Practicum and Observations at the schools located in the district.
