May 31, 2019
Monthly Budget Report**

- Operational Fund Revenues as of May 31, 2019 - \$96,812,982 which represents 92.87% of budgeted Revenues.

- Operational Fund Expenditures as of May 31, 2019 - \$85,508,319 which represents 70.66% of budgeted Expenditures.

- The May 31, 2019 Operational Fund Cash Balance before loans was \$42,083,975. The cash balance after temporary loans of \$6,487,082 to the grant funds was \$35,596,893. Grant funds that reported a negative cash balance as of May 31, 2019 totaled \$6,487,082, which represents an increase of \$2,616,235 from the April 30, 2019 negative balances.
- As of May 31, 2019, the PED and other grant funding agencies owed the District approximately \$5,469,286 for current year Grant Fund expenditures, \$1,632,693 for Capital Projects, and \$1,817,921 for Student Nutrition. These amounts are not reflected in the temporary loans noted in Item 3 above. The negative cash balances noted in Item 3 are a result of the outstanding amounts owed to the District.
- Total Revenues for all funds as of May 31, 2019- \$152,000,678. Of the total revenues received, the Operational Fund accounted for 63.69%, the Grant Funds 10.64%, Building Funds 9.75%, Debt Service Funds 7.05%, Student Nutrition 4.55%, and all the other funds 4.32%.
- Total Expenditures for all funds as of May 31, 2019- \$140,673,824. Of the total expenditures incurred, the Operational Fund accounted for 60.78%, the Grant Funds 10.89%, Building Funds 8.66%, Debt Service 9.23%, Student Nutrition 5.81%, and all other funds 4.63%.
- Direct Instruction expenditures plus encumbrances for the Operational Fund as of May 31, 2019 were \$63,490,230 or 62.55% of the total Operational Fund expenditures.
- Pledged collateral – All bank accounts in compliance at May 31, 2019. See separate report attached Item III Summary of Investments.

Selected items from April 30, 2019 Report:

1. Operational Fund Revenues as of April 30, 2019 - \$87,667,249 which represents 84.10% of budgeted Revenues.
2. Operational Fund Expenditures as of April 30, 2019 - \$76,610,527 which represents 63.31% of budgeted Expenditures.
3. Total Revenues for all funds as of April 30, 2019- \$139,993,573. Of the total revenues received, the Operational Fund accounted for 62.62%, the Grant Funds 10.89%, Building Funds 10.47%, Debt Service Funds 7.00%, Student Nutrition 4.41%, and all the other funds 4.61%.
4. Total Expenditures for all funds as of April 30, 2019- \$124,941,590. Of the total expenditures incurred, the Operational Fund accounted for 61.32%, the Grant Funds 10.47%, Building Funds 8.45%, Debt Service 9.368%, Student Nutrition 5.89%, and all other funds 4.52%.
5. Direct Instruction expenditures plus encumbrances for the Operational Fund as of April 30, 2019 were \$63,334,758 or 62.52% of the total Operational Fund expenditures.

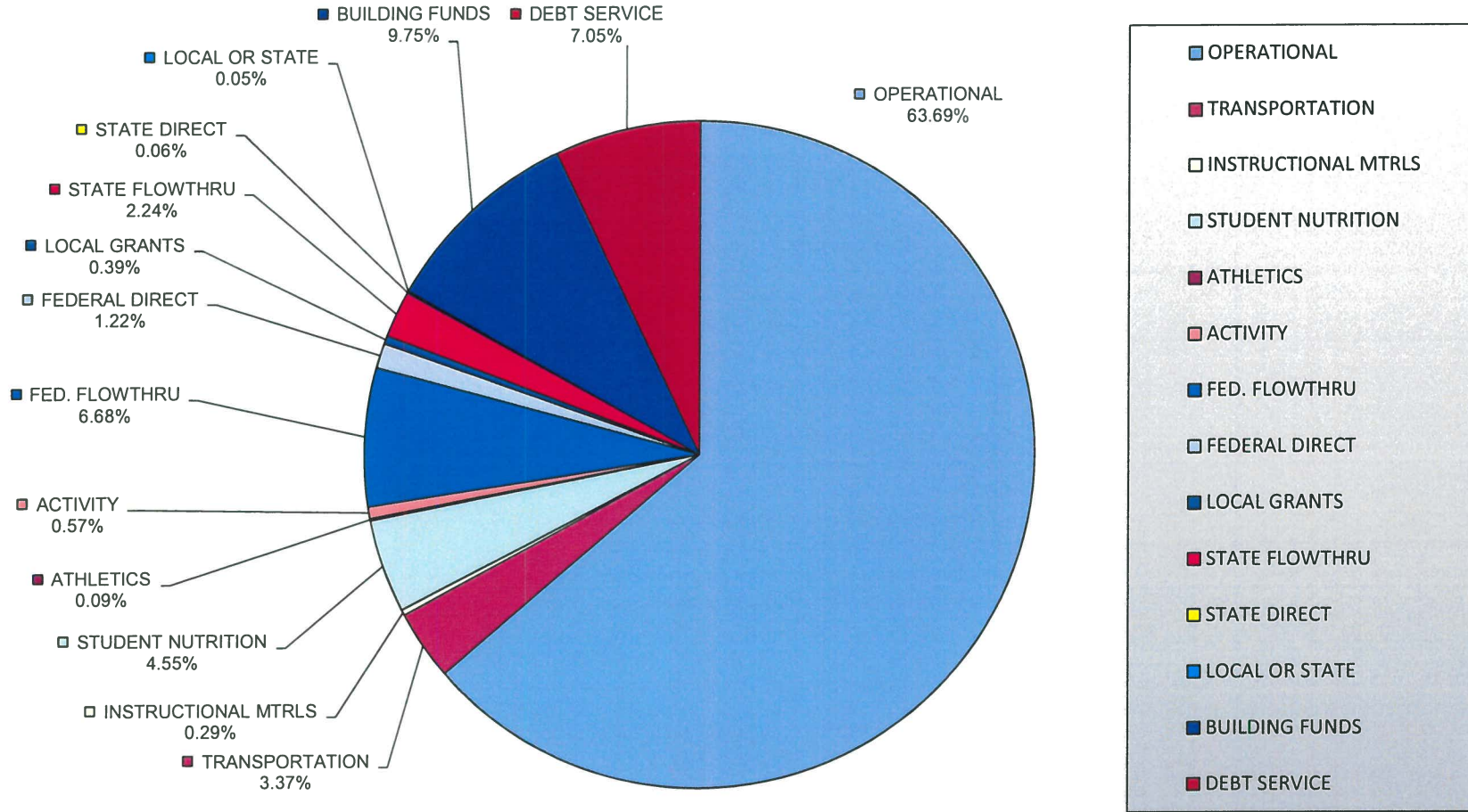

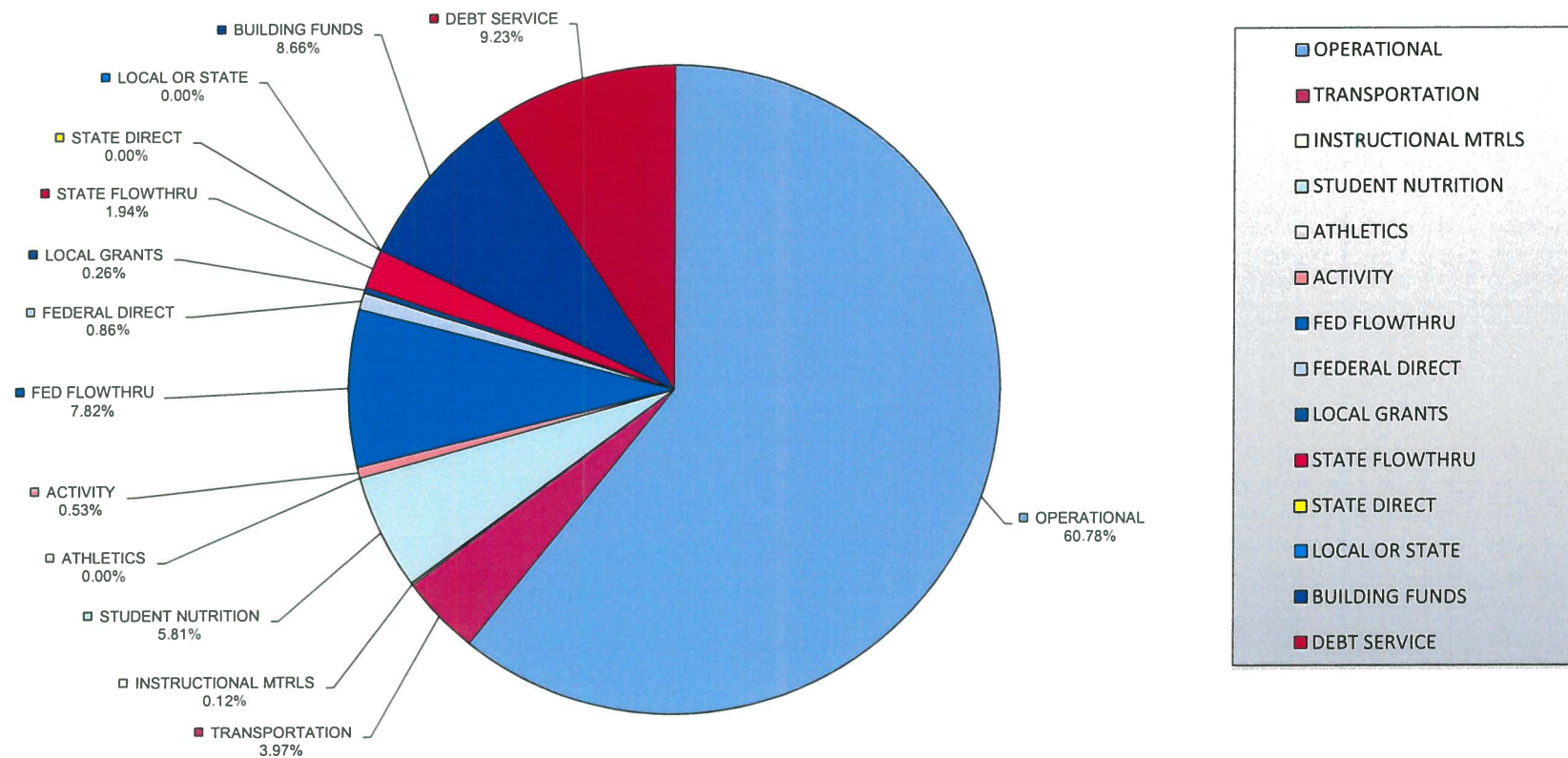

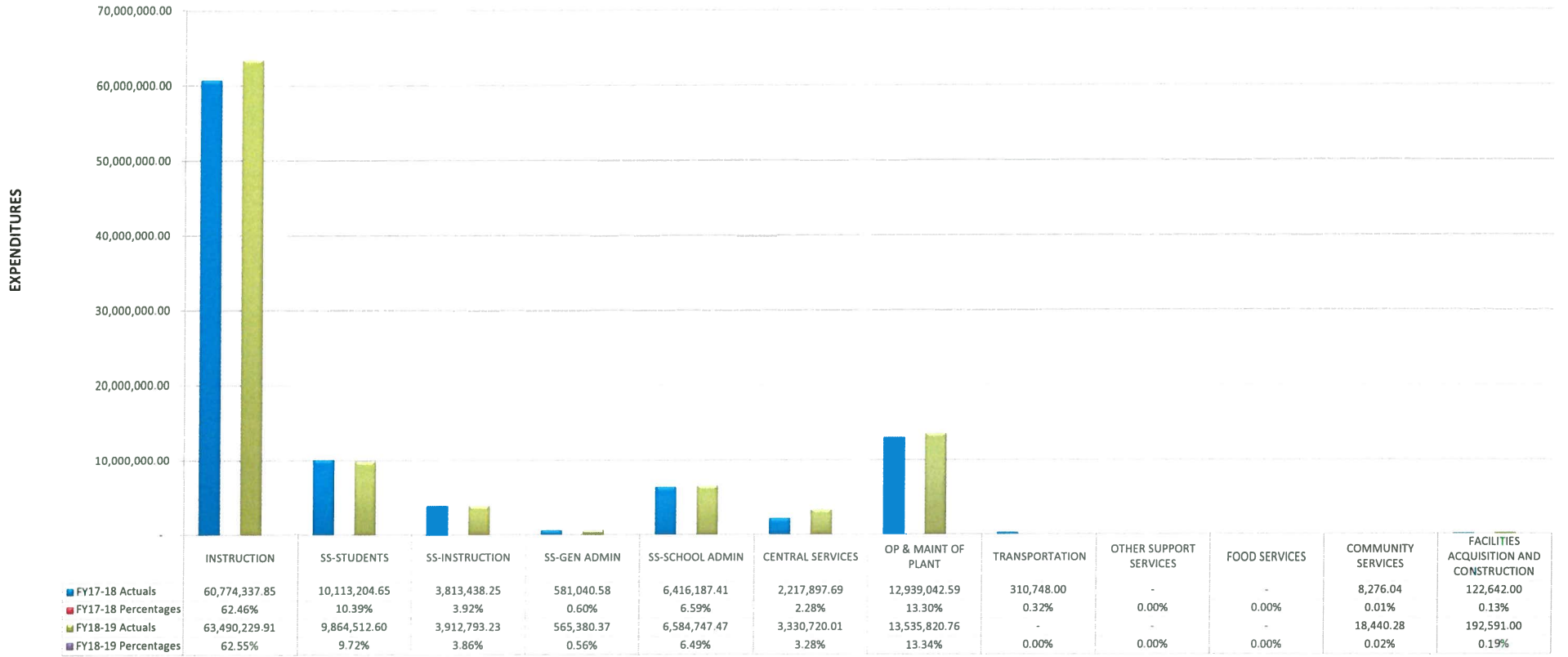
GISD 2018-19 REVENUES BY FUND MAY 2019



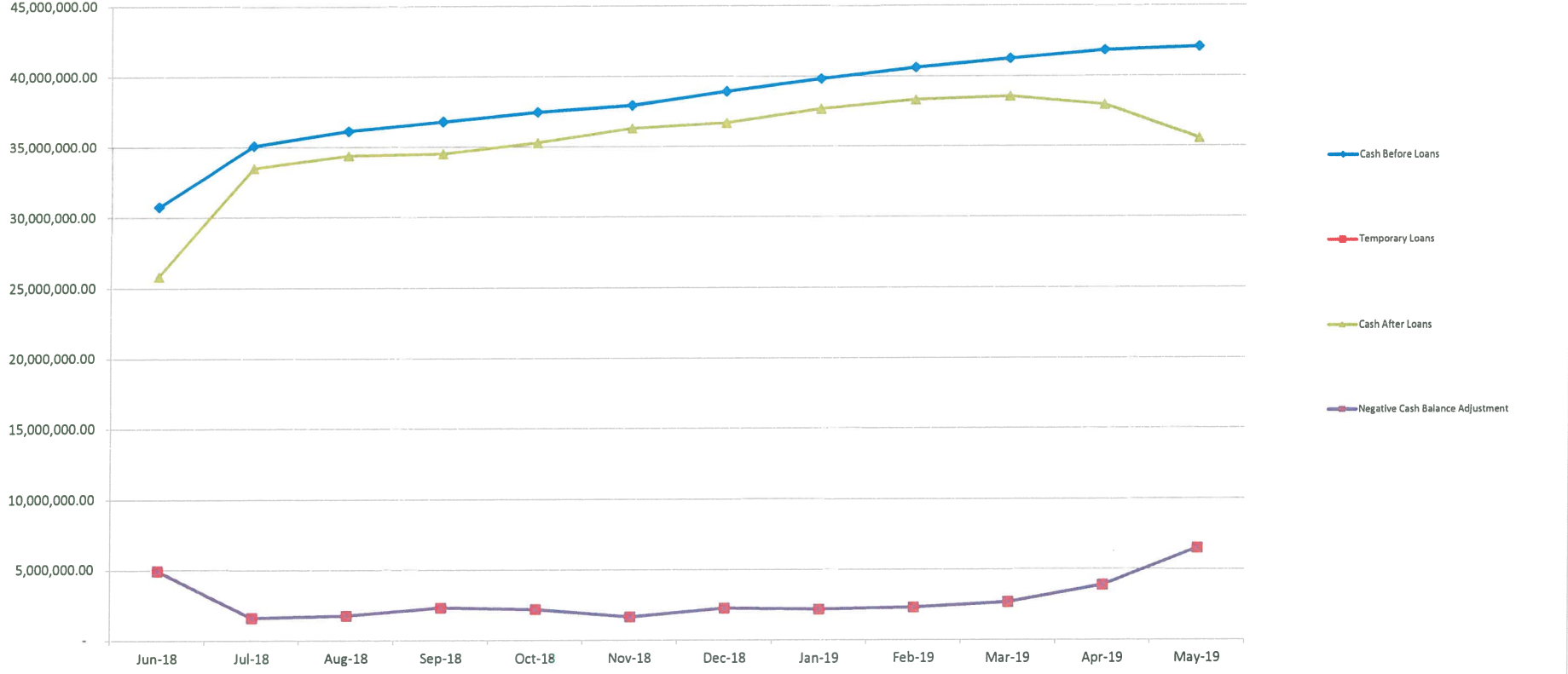
GISD 2018-19 EXPENDITURES BY FUND MAY 2019



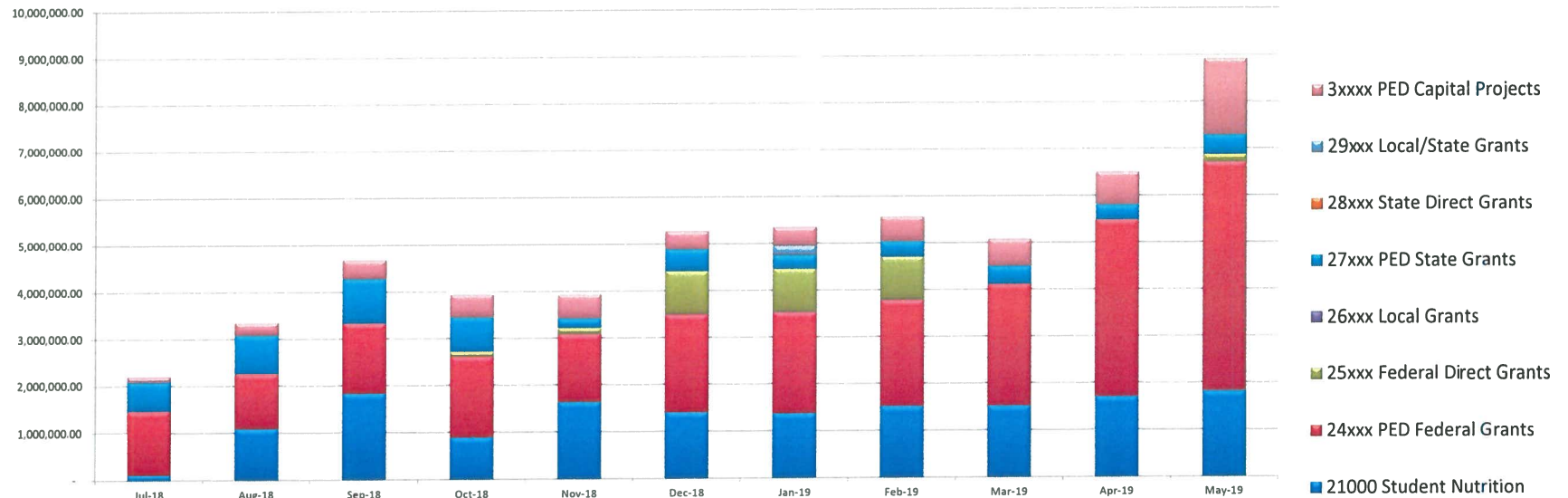
