- Reestablish Budget for Unliquidated Obligations (Encumbered Balance as of 6/30/20 of FY18-19 Redistribution) in FY20-21 through OBMS by **July 10, 2020**

Indirect Cost Rate

As required by 2 C.F.R. § 200.331(a)(4), PED recognizes the indirect cost rate between PED and Gadsden Independent Schools as calculated by PED and located on the PED website:
