He detailed that all students will be learning from home utilizing our remote learning platform. Teachers will have the option to deliver instruction from home or from their classroom during this phase. Personal Protective Equipment (PPE) has been purchased by the district and will be provided to staff who are on GISD facilities. Phasing into the NMPED approved Hybrid model will be determined by New Mexico Department Of Health (NMDOH) data, Public Health Orders and number of confirmed cases in our area.
