Introduction And Roll Call	 The Gadsden School Board convened in regular session at 5:02 p.m. President Viramontes presided at the meeting held virtually at the Gadsden Administrative Complex. Members present: Armando Cano, Daniel Castillo, Laura Salazar Flores, Claudia Rodriguez, and Jennifer Viramontes.
Pledge & Mission Statement	2. The Pledge of Allegiance and the Pledge to the New Mexico flag were recited. Claudia Rodriguez read the mission statement.
Superintendent's Report	 Superintendent District Updates and Recognitions: A. Mr. Sanchez, Principal at La Union Elementary, gave an update on La Union Elementary. He stated La Union Elementary teachers and staff continue striving to provide an education to the students, attendance rate is at 96%, Red Ribbon week was virtually celebrated, and the students will present a virtual Winter Program to parents next week.
	Mr. Wohlgemuth, Principal at Santa Teresa High School, held a moment of silence for Rosalie Cuellar, an IA SPED, who recently passed away. He also recognized Art Aguirre, Volleyball Coach, who was diagnosed with COVID-19 in late September and was critically ill. Art Aguirre stated he appreciated being recognized and to tell his story of the battle he fought with COVID-19. He thanked the Santa Teresa community for their support, love, and prayers he received during his hard time.

Staffing Models

- All schools and departments are being directed to encourage staff to work from home when possible
- Essential departments have implemented "On-call" or "cohort" schedules
- Classrooms remain available for staff who request it
- Administrative teams have been given the flexibility to implement "on-call", "cohort" or work from home schedules. This allows administrators to ensure student needs are being addressed and also reducing possible exposure points
- E. Student Representative, Ericka Chen, a junior from Santa Teresa High School, reported that at the start of the year it was difficult and quite a challenge for students and teachers to adjust and accommodate to this new way of remote learning. She noted that all embraced the use of technology which would be beneficial for when students return to classrooms. Again, there are challenges as teachers are working hard to keep up with the needs for all students. Unfortunately, things aren't as fluent in class periods as it would be in regular class environments. Ericka stated she is a member of Student Council, National Honor Society, and Band. In band they are fortunate to have six members qualify for All-State. The band director keeps them active by using Smart Music Program. Student Council is planning different activities to celebrate the Holiday Season. The National Honor Society is trying to reach out to retirement homes as a pen pal system to communicate.
