Background and Summary:

The CRRSE ESSER II Application has been submitted to the state for approval. The Director for Federal Support Services requests BOE Ratification for Submission. An attached document outlines the amount of the total award and the services that will be provided to the district through this fund.

CRSSE ESSER II 2021-2023

Total Award : \$31,462,964.60

The ESSER II fund is designed to provide funding to meet a diverse array of educational and COVID response related needs. PED strongly recommended to plan for how these resources can be used to ensure that critical program and infrastructure elements are in place to allow for a safe return to school and to mitigate interruptions to the learning process caused by COVID-19.

These priorities include:

- Closing the digital divide
- Supporting the social and emotional needs of students, families, and staff; Supporting the needs of students with disabilities and at-risk students, both during the building closure and when students transition back into school buildings
- Providing personal protective equipment for all staff and students, as well as ensuring that schools are fully cleaned, sanitized, and stocked with cleaning supplies
- Accelerated Instruction

The Superintendent and the Director for Federal Support Services have conducted extensive stakeholders surveys and meetings with different groups to discuss the use of the funds and the District priorities.

As a result of the surveys and meetings and a review of district data and DASH Plan, the following programs are proposed in the application of the ESSER II grant:

- Technology; 2 year replenishment cycle for district devices for students, completion of interactive classrooms, replenishments laptops for staff, network redesign.
- HVAC Upgrades.
- SPED Supplemental support and services for students with disabilities for whom the COVID pandemic has created additional adverse effects.
- Programs, activities and services to support unique needs of EL students.
- Mental Health services and Socio Emotional Program to support students.
- Professional Development for educators to support instructional acceleration and students socio-emotional wellbeing.
- Academic Enrichment Initiative Summer program to provide opportunities for students to improve in the areas of math and literacy.
- HQIM materials for instructional acceleration of students
- Stipends for elementary school Principals and leaders to allow them to perform duties during the summer.
- Support for CTE programs
- Additional compensation for staff who will continue working in collaboration with NMDOH providing either vaccine pods for the community or whatever is needed to respond to

COVID-19.

- Stipends for tutoring services addressing accelerated instruction for all students
- 2 Attendance advocates to support schools with Chronic Absenteeism
- 2 vehicles to support Bilingual Instructional Specialists to visit schools to support implementation of programs for EL students
- 1 vehicle for C&I Specialists to deliver HQIM materials to schools and support the implementation of accelerated instruction.
- 2 vehicles for Attendance Advocates to do home visits to students showing chronic absenteeism, to provide students and families support and guidance needed for attendance.
